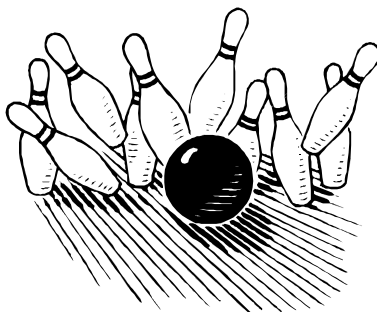

RULES FOR CONDUCTING AUBURN USBC WOMEN'S BOWLING ASSOCIATION ANNUAL LOCAL TOURNAMENT – PLEASE READ CAREFULLY – NO EXCUSES ALLOWED FOR IGNORANCE OF RULES.

1. List line-up in EACH EVENT in order of bowling formation. NO CHANGES WILL BE EXCEPT FOR SUBSTITUTES.
2. Each bowler will receive a handicap of 80% of the difference between the average and 200 in each event. All others will bowl scratch.
3. All events will be figured with handicap - \$2.00 per person extra to enter all events.
4. AVERAGE: Twenty-one games establishes an average. Entrants shall use their highest sanctioned league average as of the end of the previous winter season in the Auburn USBC WBA. If an entrant does not have a previous winter season average, average will be based as follows:
  - (a) Highest 21 games or more average in the 2008 Spring League.
  - (b) Highest 12 games or more average as of October 15<sup>th</sup> of the current season.
  - (c) Highest average for at least 21 games as of the closing of the tournament.
  - (d) An entrant without an acceptable average under any one of the stated conditions must use the highest average as of the day of the tournament.
  - (e) If no average – Bowl scratch.
- (“TEN PIN RULE WILL BE WAIVED DUE TO TIME FRAME OF TOURNAMENT”)
5. Entry blanks must be signed by the team captain and with check or money order (NO CASH) be submitted to the City Association no later than October 26, 2008. NO ENTRIES ACCEPTED AFTER October 26, 2008.
6. After an entry has been received and filed, the entry fee in no cases shall be refunded.
7. Any four women sanctioned in the AUBURN USBC WBA may bowl together as a team. Two players on a team cannot place more than once in the prize list for position standings. A woman can bowl as many times in the Team Event only. Her first Team Event score to count for All Events.
8. Bowlers entered in the Doubles Event must also enter the Singles Event. Bowlers entered in the Singles Event must also enter the Doubles Event. If one bowler is late for Doubles Event, the bowler present will bowl her Singles Event first. If her partner has not arrived by the time the Singles Event is completed, and a substitute cannot be found, she will be permitted to bowl her games in the Doubles Event in order to qualify for the All Events. IN THE DOUBLES EVENT, ONLY ONE SUBSTITUTE WILL BE ALLOWED – ONE WOMAN ENTERED, MUST BOWL AS SCHEDULED.
9. Paid ALL EVENTS are not transferable unless a substitute replaces the original entrant in all three events and the transfer is made by a tournament official prior to the substitute's participation in any event.
10. All captains shall report line-up to the Secretary's office 30 minutes before time scheduled to bowl. ALL Events will start promptly as scheduled.
11. Teams will be matched according to average, as closely as possible, and LANES WILL BE ASSIGNED.
12. Any appeal or protest shall, in all cases, be made in writing and submitted no later than 24 hours after the game has been played. This appeal or protest shall briefly state the grounds for appeal or protest. The action of the Board of Directors on this appeal or protest shall be final.
13. ALL ENTRANTS MUST BE IN GOOD STANDING.
14. Arm patches, chevrons and trophies will be awarded to the highest handicap winners in Team, Doubles, Singles and All Events. All Events trophy will be given for scratch total. Cash prizes will be awarded for all events with handicap, Rule 216 will apply.
15. All Prize money will be paid at an open meeting of the Association, TBA. At least one prize for every ten entries.
16. For further rules and information, consult your Rule Book or Tournament Secretary.
17. The entrants whose name appear on the entry form or their authorized replacements hereby agree that the Auburn USBC WBA, its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule change or premature termination of the tournament, which may be brought about by war, national emergency or emergency of causes relating thereto or resulting there from, fires, strikes, lockouts, labor difficulties or other causes beyond the control of the Auburn USBC WBA.
