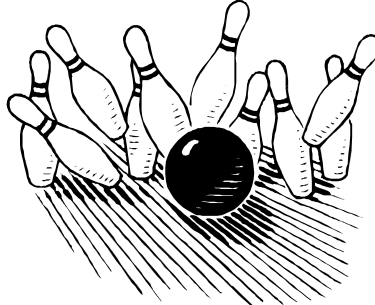

RULES FOR CONDUCTING AUBURN USBC WOMEN'S BOWLING ASSOCIATION ANNUAL LOCAL TOURNAMENT – PLEASE READ CAREFULLY – NO EXCUSES ALLOWED FOR IGNORANCE OF RULES.

1. List line-up in EACH EVENT in order of bowling formation. THERE WILL BE NO CHANGES EXCEPT FOR SUBSTITUTIONS.
2. Each bowler will receive a handicap of 90% of the difference between the average and 215 in each event. All others will bowl scratch.
3. AVERAGE: Twenty-one games establishes an average. Entrants shall use their highest sanctioned league average as of the end of the previous winter season in the Auburn USBC WBA. If an entrant does not have a previous winter season average, average will be based as follows:
 - (a) Highest 21 games or more average in the 2010 Spring League.
 - (b) Highest average for at least 21 games as of the closing of the tournament.
 - (c) An entrant without an acceptable average under any one of the stated conditions must use the highest average as of the day of the tournament.
 - (d) If no average – Bowl scratch.
5. Entry blanks must be signed by the team captain and submitted with check or money order (NO CASH) to the Auburn USBC WBA no later than October 20, 2010 TO HOLD RESERVATION.
6. After an entry has been received and filed, the entry fee in no case shall be refunded.
7. Any four women sanctioned in the Auburn USBC WBA may bowl together as a team. At least (2) players must be different on a team to cash in the standings. A woman can bowl on multiple teams.
8. All captains shall report line-up to the Secretary's office 30 minutes before time scheduled to bowl. ALL SQUADS will start promptly as scheduled.
9. Teams will be matched according to average, as closely as possible, and LANES WILL BE ASSIGNED.
10. Any appeal or protest shall, in all cases, be made in writing and submitted no later than 24 hours after the game has been played. This appeal or protest shall briefly state the grounds for appeal or protest. The action of the Board of Directors on this appeal or protest shall be final.
11. ALL ENTRANTS MUST BE IN GOOD STANDING AND PROPER ATTIRE IS REQUIRED.
12. Awards will be presented to the highest handicap winners.
13. At least one prize for every ten entries.
14. For further rules and information, consult your Rule Book or Tournament Secretary.
15. The entrants whose name appear on the entry form or their authorized replacements hereby agree that the Auburn USBC WBA, its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule change or premature termination of the tournament, which may be brought about by war, national emergency or emergency of causes relating thereto or resulting therefrom, fires, strikes, lockouts, labor difficulties or other causes beyond the control of the Auburn USBC WBA.
